

Pensioners/ Family Pensioners whose PPO(s) have been issued and retirement benefits settled/paid by KVS(RO) Mumbai are requested to forward their pension related grievance, if any to the Finance Officer KVS RO Mumbai in two copies containing all relevant details viz Name and Designation of the pensioner/ Family pensioner, Date of retirement/death/Name of KV/RO in which the pensioner/deceased employee (pensioner) served and post held by him, PPO number, Name and address of pension disbursing authority (paying branch of SBI), Current correspondence address and contact number etc. alongwith full details of their grievance which should reach KVS (RO) Mumbai on or before 14.09.2018.

1. The revision of pension as per VII CPC is under process at CPPC, SBI Belapur, New Mumbai & likely to be disbursed by the end of September 2018.
2. Cases involving purely legal points eg. Succession etc. and the grievances involving policy matters cannot be taken up in the Adalat.
